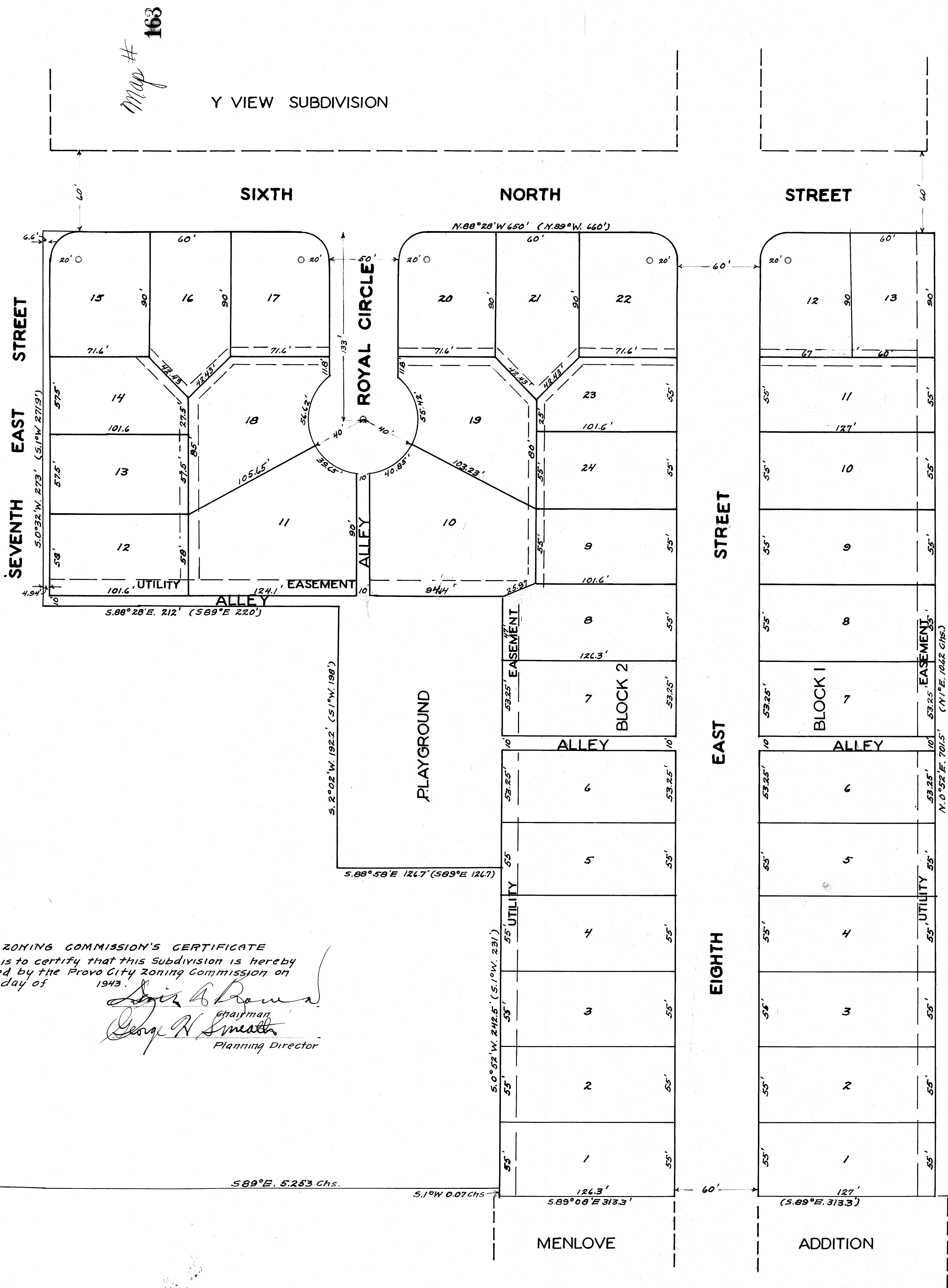
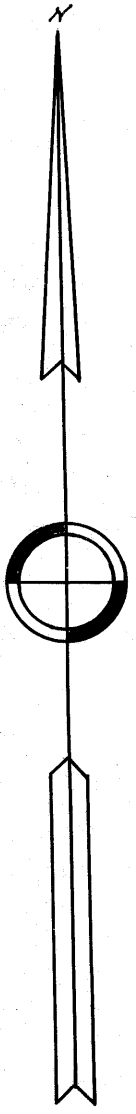


PLAT B

ENGINEER'S CERTIFICATE
 I hereby certify that I have surveyed the land shown on this map and that the plat thereof showing its division into Lots, Blocks, Streets, Alleys and Easements is true and correct. The land is described as follows:
 Commencing 186 chain East and 5.253 chains $5.89^{\circ}E$ and 0.07 chains $5.1^{\circ}W$ of the southwest corner of the Northeast quarter of Section 6, Township 7 South, Range 3 East of the S.L.B. & M.; thence $5.89^{\circ}E$ 4.747 chains; thence $N.1^{\circ}E$ 10.62 chains; thence $N.89^{\circ}W$ 10 chains; thence $5.1^{\circ}W$ 4.12 chains; thence $5.89^{\circ}E$ 3.333 chains; thence $5.1^{\circ}W$ 3 chains; thence $5.89^{\circ}E$ 1.32 chains; thence $5.1^{\circ}W$ 3.5 chains to the place of beginning.
